Information on the processing of personal data pursuant to articles 13 and 14 of EU Regulation no. 679/2016 of 27 April 2016

TYPES OF DATA PROCESSED

Data collected during registration

Navigation data and cookies

PURPOSE OF DATA PROCESSING

LEGAL BASES OF DATA PROCESSING

The processing of Data for the purposes indicated in the preceding paragraph is carried out to allow you to correctly navigate the Site and to use the related Services and therefore does not require your express consent (pursuant to Article 6.1 letter (b) of the Regulation).

SCOPE OF COMMUNICATION AND DISSEMINATION OF DATA

The Data you provide will be processed in compliance with the Regulation and, in any case, in such a way as to guarantee the security and confidentiality of the same, to prevent unauthorized disclosure or use, alteration or destruction. The processing of Data will take place on paper and / or electronically, also with the aid of electronic and informative means.

The Data Controller will process your Data in its technological infrastructure and / or using the technological infrastructures of third-party suppliers appointed as data processors.

PERIOD OF STORAGE OF PERSONAL DATA

The Data collected for the processing purposes indicated above will be kept until your express request for deletion of the Data, except in the case of exceptional need for the Data Controller to keep the Data to defend its rights in relation to disputes arising at the time of the request or on the indication of the public authorities.

The deletion of the Data will, however, make it impossible to use the Services provided by the Site.

RIGHTS OF THE INTERESTED PARTY

You will be able to know what your data are processed and where the conditions are met, exercise the various rights relating to their use (right of access, rectification, updating, integration, cancellation, revocation of consent to processing, right to obtain a copy of your data where they are stored in countries outside the European Union, as well as to obtain indication of the place where such data are stored or transferred) by making an explicit request to the Data Controller at the following address: info@tiroart.com.
